## **SECURITY CLEARANCE INFORMATION – a must read!**

This information will then be sent to the State Dept. for your security clearance, which requires at least 45 days to process.

Whatever form of ID that you mail to the ILR office **must** be the same one you will take with you to verify ID when we arrive at the State Department. If you do not provide this information, you will be turned away by the State Department. This is State Department policy, not the policy of the ILR.

Please be aware that after the cancellation date there will be no refunds or substitutions for this trip, as there will be no time for clearances for additional people. If the trip is cancelled due to lack of participants, your money will be refunded.

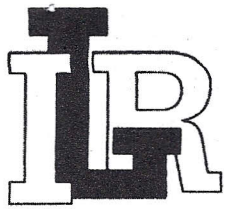
